#### A message from our NCRC President: Norm O'Brien

Welcome to my November note from North County Republican Club. Our October meeting consisted of a presentation by Jolie Diane who is an investigative journalist who uses the results of her investigations to spur community activism and change laws to help control the problems she finds. Her talk centered around WFI and the Electro Magnetic Frequencies that proliferate our homes, schools, and all public spaces. Cell phones are the primary benefit of the many cell towers that you see. Jolie pointed out that these towers are not regulated, and EMF sources can be put up indiscriminately on these towers. She also demonstrated that your cell phone is also the source of EMF and there are steps you can take to minimize it. What was most astounding was that there has been very little testing, if any, about the safety of this radiation.

**Our November meeting** was supposed to be a presentation by the conservative candidates for the Anne Arundel County School Board. Unfortunately, with our county's 7 districts, there are only two candidates registered at this time. We will have Jamie Hurman-Cougnet (District 3) and Latoya Nkongolo (District 5) who are both standing up to run for the board. They will present their background and lay out their positions on school board issues. We invite anyone who has problems with our current education system to attend along with those who might be interested in running for the school board. In addition to the school board candidates, we will hear from Candance Parrott, who will provide a presentation on Child Sex Trafficking. Candace works for Araminta, a Baltimore based non-profit organization, teaching local communities how to keep our children safe from predators.

#### Have you read any good books lately?

Well, I'm in the process of reading one, but first let me give you a little background. In 1932, "A Brave New World" by Aldous Huxley was published. It was the first of 2 dystopian (the opposite of utopian) books in the 20th century. The other book was "1984" by George Orwell and that was published in 1946. Both books were novels in which the government controlled our

every thought. In the first, sex was outlawed and the government with its perfect knowledge would grow children from the lab to produce the elites and the workers. The second was where the government spied on everyone and relied on fear to obtain obedience. Well, Aldous Huxley published "Brave New World, Revisited". That's the book I'm reading now. He published it in 1958 and claims that the future will not be ruled by fear, but by the government giving everything to everyone to induce compliance. He quite accurately predicts the world we now see, and he did this 65 years ago. This book is not huge, just over 100 pages but is not an easy read. It's available both on Amazon and Thrift books for about \$10. I recommend it.

#### Did you know - Upcoming legislation?

During the last Maryland legislative session, a bill was introduced in both the house and the senate titled, "Declaration of Rights - Religious Freedom, Religious Tests, and Oaths and Affirmations". The bill removed requiring the belief in God from our constitution. The bill argues that what it proposes has already been written and affirmed in the US Constitution and supported by lower court rulings. My concern is that the bill takes a sludge hammer to the Maryland Constitution and only a retuning of the wording is necessary. It destroys completely the thoughts in our Declaration of Independence that we are endowed by our creator with inalienable rights. They went too far. Anyway, the bill died in committee, but it will come back in 2024. So, it stays in committee, I recommend you comment on the bill when it is introduced at that time.

This leads to the question of "How do I know when it is introduced?" and "How do I comment on the bill?". I'll answer those two questions below.

"How do I comment on the bill?" I answered this question in our February 2023 Newsletter, my first one as president. It just got a lot easier with the help of the State of Maryland and some hard work by a few Republicans.

The State of Maryland set up a web page, MyMGA, to make it easier for you to request to testify or provide comments on an upcoming bill. Once you get to that page and register, you will have access to all the bills that come before the general assembly. You can select the bill you are interested in and request to have an oral testimony or provide a written testimony. This will go to each legislator involved with the hearing for this bill. The hearing process is the most important part of a bill becoming law. That's where the committee that hears the bill makes the decision to change the bill. At later stages, the bill can only be amended, and it is much harder, although possible. If good arguments are presented, it could kill or weaken a bill.

Senate bills have only a one-day window and house bills have only a two-day window ahead of the bills hearing. So, you only have one or two days ahead of the hearing to sign up to testify on that bill. So timing is of the essence. Here's the details on how to register.

In the upper right corner of that home screen is a small icon labeled My MGA. Click on that and you can register with the system. You must register to use the system. It should be fairly easy to use this site, and there is a YouTube video put out by a Baltimore County Republican Women's Group led by Kate Sullivan that walks you through the whole process at <a href="https://www.youtube.com/watch?v=rei9NVIKtsA">https://www.youtube.com/watch?v=rei9NVIKtsA</a>

It's about 40 minutes long and well worth watching it.

#### "How do I know when it is introduced?"

You are now one of the 1% who have read this far, so you must really be interested. Send me an email with "Legislative Testimony" in the subject line. I will put you on the distribution for emails that contain a spread sheet showing the bills submitted, an analysis of them and dates for their review, as much as possible. You then go to your MyMGA page for House and Senate bills that are up for hearings on Senate and House. All bills open for voting/testimony signup for today will be <a href="highlighted in yellow">highlighted in yellow</a>. Topics include Climate Change, Parents' Rights, Inappropriate topics taught to school students, 2nd Amendment, Privacy, Public Health, and Gender Inclusivity. The period for voting is listed. Be sure you have access to Microsoft Excel because that's the app that will be used. I will be awaiting your email.

## NCRC Membership: Join or Renew

### Mail In Ballots - - - They make a difference!

### Why Should I Use Mail In Ballots? This year and in the future.

In general, the use of Mail In ballots in a voting system is a bad idea. It introduces more opportunity for fraud than Election Day in person voting. However, if your state legislates Mail In ballots like Maryland, you should use them. Why?

- 1. They are safe. The ballot is sent to you with a unique return envelope which is the only one the elections board will accept. Without the return envelope the ballot will not be counted.
- 2. They are secure. This is especially true if the ballot is returned in the ballot drop box. The drop boxes are more secure than the Post Office.
- 3. They are reliable. **Can you** be absolutely, positively, sure you will get to the polls on Election Day? You won't be sick, have an emergency, etc. No, you can't.
- 4. They provide protection against fraud. In the unlikely event some fraudster uses your identity to obtain your Mail In ballot you have time to challenge this. You will get your lawful ballot and void his illegal ballot. If you wait until election day, it may be too late. The fraudulent ballot may be counted and yours may not.
- 5. They are convenient. You can study the candidates and issues before you vote.
- 6. Elections matter, they determine who will legislate and thus the future election system. Using the current election system is the ONLY way to affect future changes.
- 7. Finally, you can track your ballot as it progresses through the process. Kinda like a package from Amazon.

## Election News: 11/09/23 Become an AA County Election Judge.

Attached is the current report of all Election Judges that have filed to work during Primary Early Voting and Primary Election Day 2024.

If you review the report, you will see that as of 11/09/23:

**Democrat judges:** 715 or 56.4% **Republican judges:** 349 or 27.5% Unaffiliated judges: 203 or 16.0%

Being on the Anne Arundel County Board of Elections for the past eight years, I can tell you the best place for Republicans to be for Primary Early Voting and Primary Election Day is inside the polling places as Election Judges. If Republicans are not working the polls, then Democrats will be in charge.

#### Observer vs Election Judge:

**Observer:** Can watch the election process without interfering with the Election process. This could be at quite a distance where detailed overview of Election processes is minimal. Ability to intervene immediately may be diminished due to no official authority to interrupt or question the process.

**Election Judge:** Part of the Election process. Judges are present when equipment is configured and initialized before Election Day begins. Judges are also present after Voting closes and are part of the final processing, closure of the equipment, reconciliation, and shut down of equipment. Election Judges are paid for training, set up the day before the Election, and working Election Day. If an election judge sees an issue, this judge can become involved immediately in the process to resolve the issue.

If you are truly concerned about Voter Integrity, then insert yourself in the place that will give you the authority to correct voting issues while these issues are occurring. I have included a link to the Board of Elections - Election Judge page.




