## **A message from our NCRC President: Norm O'Brien**

Are you prepared for the year 2024? We're one year closer to Klaus Schwab's prediction for 2030 of "You will own nothing and be happy". If you don't know who Klaus Schwab is, he's the head of the World Economic Forum (WEF) and the Author of the "Great Reset". Are you ready for his prediction? Their plans are moving swiftly. We've been haunted by food shortages over the past year. We've had a major pandemic that forced us to stay at home, wear masks, keep 6 feet apart, and stop shaking hands. We've become accustomed to constant forecasts of yet newer contagious illnesses that would necessitate more and more vaccines. Bill Gates is funding vaccines that are in wafer form or could be administered by an injection under the skin. Have you heard of the mark of the beast? We're constantly told that we shouldn't eat meat, but bugs are good for you. Our country is \$33 trillion in debt, and Klaus himself told us we will experience a major cyber-attack this year. Our social order is breaking down with our teachers saying that America is a bad country and was founded on slavery. It's all documented in the "1619 Project". It's normal to have multiple genders and what's more is, you can change your gender with chemicals and operations that are covered by insurance. We try to make some sense of this in an election year where the front runner for president is under indictment and faces tens of years behind bars and is being barred from running in a few states. Our state is asking us to make abortion a right up to the time of birth. Other than that, and still more dystopia, Happy New Year.

Knowing the above is the first step in stopping its advance. We need to arm ourselves with the knowledge of what they're saying and build defenses against it. We need to make our families, neighbors, friends, and acquaintances aware of these things that are happening so they too can join us in stopping it.

### **Maryland Constitutional Amendment: Maryland Right to Reproductive Freedom Amendment**

Speaking of the abortion amendment that we will be voting on in November, I sent the following note to the pastor of my church back in December. He has yet to reply. The last time politics was mentioned from the pulpit at my church was during the last legislative assembly where the Maryland General Assembly voted to remove the date restrictions on making a legal claim if you were injured by sexual abuse by the clergy. We were urged to contact our legislators to request them to vote against the removal of the time restrictions. I did not do that. That was not what Jesus had in mind when he asked the apostles to feed my sheep. Anyway, my note follows:

"As you said in yesterday's sermon, **God is at work.** He has been gnawing at my heart for some time now, and like Jonah, I've been ignoring him. I say it is too hard, but he keeps gnawing. Since I don't want to end up like Jonah, I'm asking you for help.

The church has been very quiet on political issues, even ones that go against everything Catholic. One such issue is the one that needs attention. I'm offering myself to bring the issue to your parishioners.

That issue is abortion; the particulars are all in a Maryland Constitutional amendment. Our run-away general assembly went a step too far, in their approval, of an amendment that grants Marylanders the right to an abortion, up to and including, the time of birth. This amendment will be on the ballot in less than 11 months. I fear many your parishioners will vote to approve it, the so-called choice Catholics. The title of the amendment is "The Right to Reproductive Freedom". What a beautiful thing, who wouldn't be for that. Everyone should have reproductive freedom. God is telling me that if they knew what was in that amendment, they would defeat it. They just need to know, and I am that messenger.

I propose that I speak before every mass on a weekend of your choosing and go into detail on why this is a bad thing to do, even for pro-choice Catholics. I will submit my talk to you for your complete editorial control. When can I send you my draft?

If for some reason you would rather present the issue, I'd be happy to give you the rationale for my thinking that this is a bad law and that it should be nowhere near our constitution.

Jesus said, "Feed my sheep!"

Anyway, I still feel that God is calling me to spread this word however I can. I'm planning a trip to a former abortion center right here in Severna Park to see what the procedure is for an abortion in the third trimester. Right now, according to Maryland law, abortion is legal up to the time of viability and after that only if the patient's life is endangered or there is a fetal abnormality. The above amendment would make abortion legal up to the time of birth which means the "baby" would be viable. I've googled for the procedure used in such cases and they stated that only one percent of the 30,000 abortions performed yearly in Maryland are in the third trimester, and the procedure used talked about a "Dilation and Evacuation" procedure which is used in the second trimester. That means that ~300 third trimester babies will be killed each year. **Could you sleep at night knowing approval of this amendment would allow this to happen?**

Following the dinner, the Warrior Canine Connection awarded a challenge Coin to our club. We will display it at our monthly meetings.

**Lastly, I'd like you to come to our January meeting where we will have a talk by an NRA board member and, a member of their Institute of Legislative Action. That's the part of the NRA that specializes in pushing legislative action across the country. Cathy Wright will bring us up to date on what is planned and already underway here and elsewhere.**

We will have Pat McDonough speak at our February meeting. He is from Baltimore County, hosts a 2-hour program on WCBM, is up on current events, and presents them in a colorful manor. His speeches are always well received.

**Did you know - Upcoming legislation?** During the last Maryland legislative session, a bill was introduced in both the house and the senate titled "Education Mandates Excluding Parents and Removing local Control". How obvious is the intention of this bill? The bill would introduce explicit sexual conduct to kindergartners and above, of course with no parental input. In fact, schools will not be required to communicate with parents, and this removes parents' ability to opt out of this curriculum. It also requires all counties to implement these plans or lose 20% of their funding. If you have kids in county schools, either take them out or send multiple notes to your district delegates and your senator. Remember, the legislative session starts this month.

I received broad support for describing last month how someone could know about upcoming bills and how they could comment on them. I will continue to keep this in the newsletter as it is needed for future reference. This leads to the question of "How do I know when it a bill is introduced that would affect me?" and "How do I comment on the bill?". I'll answer those two questions below.

#### **"How do I comment on a bill?"**

I answered this question in our February 2023 Newsletter, my first one as president. It just got a lot easier with the help of the State of Maryland and some hard work by a few Republicans. The State of Maryland set up a web page, MyMGA, to make it easier for you to request to testify or provide comments on an upcoming bill. Once you get to that page and register, you will have access to all the bills that come before the general assembly. You can select the bill you are interested in and request to have an oral testimony or provide a written testimony. This will go to each legislator involved with the hearing for this bill. The hearing process is the most important part of a bill becoming law. That's where the committee that hears the bill makes the decision to change the bill. At later stages, the bill can only be amended, and it is much harder, although possible. If good arguments are presented, it could kill or weaken a bill.

Senate bills have only a one-day window and house bills have only a two-day window ahead of the bills hearing. So, you only have one or two days ahead of the hearing to sign up to testify on that bill. So timing is of the essence.

#### **Here's the details on how to register:**

Go to <https://mgaleg.maryland.gov/mgawebsite#>. In the upper right corner of that home screen is a small icon labeled MyMGA. Click on that and you can register with the system. You must register in order to use the system. It should be fairly easy to use this site, and there is a YouTube video put out by a Baltimore County Republican Women's Group led by Kate Sullivan that walks you through the whole process at <https://www.youtube.com/watch?v=rei9NVIKtsA>. It's about 40 minutes long and well worth watching it.

#### **"How do I know when a bill is introduced?"**

You are now one of the 1% who have read this far, so you must really be interested. **Send me an email at [ngobrie@verizon.net](mailto:ngobrie@verizon.net) with "Legislative Testimony" in the subject line.**

I will put you on the distribution for emails that contain a spread sheet showing the bills submitted, an analysis of them and dates for their review, as much as possible. You then go to your **MyMGA** page for House and Senate bills that are up for hearings on Senate and House. All bills open for voting/testimony sign up for that day will be **highlighted in yellow**. Topics include: Climate Change, Parents' Rights, Inappropriate topics taught to school students, 2nd Amendment, Privacy, Public Health, and Gender Inclusivity. **The period for voting is stated**. Be sure you have access to Microsoft Excel because that's the app that will be used. **I will be awaiting your email.**

## Become an AA County Election Judge.

Attached is the current report of all Election Judges that have filed to work during Primary Early Voting and Primary Election Day 2024.

If you review the report, you will see that as of 11/09/23:

**Democrat judges:** 715 or 56.4%  
**Republican judges:** 349 or 27.5%  
**Unaffiliated judges:** 203 or 16.0%

Being on the Anne Arundel County Board of Elections for the past eight years, I can tell you the best place for Republicans to be for Primary Early Voting and Primary Election Day is inside the polling places as Election Judges. If Republicans are not working the polls, then Democrats will be in charge.

### Observer vs Election Judge:

**Observer:** Can watch the election process without interfering with the Election process. This could be at quite a distance where detailed overview of Election processes is minimal. Ability to intervene immediately may be diminished due to no official authority to interrupt or question the process.

**Election Judge:** Part of the Election process. Judges are present when equipment is configured and initialized before Election Day begins. Judges are also present after Voting closes and are part of the final processing, closure of the equipment, reconciliation, and shut down of equipment. Election Judges are paid for training, set up the day before the Election, and working Election Day. If an election judge sees an issue, this judge can become involved immediately in the process to resolve the issue.

If you are truly concerned about Voter Integrity, then insert yourself in the place that will give you the authority to correct voting issues while these issues are occurring. I have included a link to the Board of Elections - Election Judge page.

# Mail In Ballots - - - They make a difference!

## Why Should I Use Mail In Ballots? This year and in the future.

In general, the use of Mail In ballots in a voting system is a bad idea. It introduces more opportunity for fraud than Election Day in person voting. However, if your state legislates Mail In ballots like Maryland, you should use them. Why?

1. They are safe. The ballot is sent to you with a unique return envelope which is the only one the elections board will accept. Without the return envelope the ballot will not be counted.
2. They are secure. This is especially true if the ballot is returned in the ballot drop box. The drop boxes are more secure than the Post Office.
3. They are reliable. **Can you** be absolutely, positively, sure you will get to the polls on Election Day? You won't be sick, have an emergency, etc. No, you can't.
4. They provide protection against fraud. In the unlikely event some fraudster uses your identity to obtain your Mail In ballot you have time to challenge this. You will get your lawful ballot and void his illegal ballot. If you wait until election day, it may be too late. The fraudulent ballot may be counted and yours may not.
5. They are convenient. You can study the candidates and issues before you vote.
6. Elections matter, they determine who will legislate and thus the future election system. Using the current election system is the ONLY way to affect future changes.
7. Finally, you can track your ballot as it progresses through the process. Kinda like a package from Amazon.

## **Education Mandates Excluding Parents**

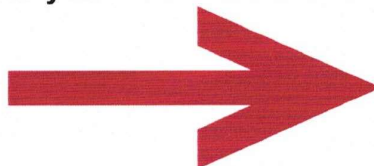

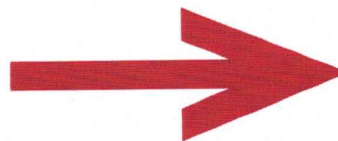
