Our June Feature Speaker - Laura Bogley, J.D

As chairperson of the Verizon Good Government Club PAC, she facilitated the company's employee political fundraising for the state of Maryland and managed consultants in financial compliance. Laura has held government affairs positions at each level of government, serving elected members of national, state and county legislatures. She has extensive training in legislative advocacy through the Advocacy Institute, Maryland Association of Nonprofit Organizations, and congressional internships.

Laura's greatest public policy success to date has been uniting the pro-life community in Maryland to defeat a 2020 legislative attack on the God-given and unalienable right to life that otherwise would have established a state Constitutional right to taxpayer funded abortion on demand.

We have invited the candidates for the upcoming election to our meeting for our "Town Hall" Do you feel that this election is the most important in our country's history? Do you find it hard to get people interested enough to work to drive the outcome of the election? Well, we do too! The NCRC is holding a Town Hall meeting on June 20th. You and your friends, club members, or constituents are invited to attend. We would like to get the best minds in the county together to investigate the issues that prevent us from energizing our base, coming up with some goals, developing tasks to meet those goals, and then going to work. Come participate and let's discuss this with the candidates.

A Message from our President - Norm O'Brien:

Welcome to our June message. The primary election is over, and our candidates have been selected. The Board of Election cut out one day for counting the mail-in ballots, so the ballots returned were probably not in the numbers that were mailed out. My guess is that there were about 2,000 ballots that were mailed out but were not voted. This is something we can take advantage of in the fall election. Now, the winners go on to the general election in November. For us in Anne Arundel County, we have Donald J. Trump for President, Larry Hogan for Senate, Rob Steinberger for Congress in the third Congressional District, Michele Talkington for Congress in the fifth Congressional District, and school board candidates [Chuck Yokum (District 3), LaToya Nkongolo (District 5), Edilene Barros (District 6), and Dawn Pulliam District 7)]. If you want to make a difference in our future, support these candidates as much as you can, through contributions, door knocking, or sign waving. Please know that Rob Steinberger is the only candidate running that is a member of our club.

We had an excellent speaker at our May meeting. Mike Peroutka spoke about the Constitution, both US and Maryland. While the US Constitution has 10 items in the bill of rights, the Maryland Constitution has 47 items in its declaration of rights. Kudos to Johnny who knew the 5 rights spelled out in Amendment 1 and he also knew the contents of the 8th and the 3rd amendments. Michael was amazed. For us mortals, those rights are the following:

1. Freedom of Religion
2. Freedom of the press
3. Freedom of Speech
4. Freedom to assemble and
5. Freedom to address our grievances.

Michael introduced his talk with the Declaration of Independence, the opening of which gives one group the right to disassociate itself with another, meaning the colonies throwing off the yolk of the king. It then lists 37 grievances with the king, most of which have been resolved with our Bill of Rights. He then stated my favorite statement from Thomas Jefferson, "If a nation expects to be ignorant and free... it expects what never was and never will be." Meaning we need to keep up with current events, join republican clubs, and elect candidates who follow the constitution.

A key part of his talk was in reference to Article 44 of the Maryland's Constitution Declaration of Rights which reads

"Art. 44. That the provisions of the Constitution of the United States, and of this State, apply, as well in time of war, as in time of peace; and any departure therefrom, or violation thereof, under the plea of necessity, or any other plea, is subversive of good Government, and tends to anarchy and despotism."

The "law" passed by the Assembly and signed by the Governor purportedly gives them the right, because of the COVID emergency, to require masks, limit access to public buildings, and require distancing without recourse, violates our freedoms. Because this "law" violates our freedoms, it is no law at all.

The constitution is the only contract between "We the People", and the government. "We the People" need to hold the government to this contract otherwise we will gradually slip into socialism or something worse. The problem is that we are not doing our job, because most of us don't know what is in the constitution. It is our responsibility to know that. Even if we do try, sometimes the courts cry that "standing" is required. Michael said that this could be a judicial trick to stop cases that courts don't want to hear. We need to keep trying. Michael is the founder of the Institute on the Constitution and encouraged all to investigate it for detailed courses on the Constitution. You can find out more information at www.theamericanview.com. If you would like to hear a weekly one-hour presentation on the Constitution, you can check out the weekly podcasts from station WFYL in Pennsylvania. It is the biblical view, leaning heavily on the bible. From the website at www.1180wfy.com, go to podcasts and scroll down to the bottom and click on "We the People". You will then have access to 2 years of commentary on the current Constitution, a proposed new Constitution, and the history of world government.

Unless you've heard it elsewhere, we were in the month of the "Natural Family". It runs from Mother's Day to Father's Day celebrating the entire natural family. Between those Sundays were Children's Day, followed by Grandparent's Day, extended family day, and finally, Father's Day. This was originated to counter the push for recognizing gays, transvestites, and all the unnatural families which are now prevalent in our society, and we are "celebrating" in June.

Mail In Ballots - - - - They make a difference!

Why Should I Use Mail In Ballots? This year and in the future.

In general, the use of Mail In ballots in a voting system is a bad idea. It introduces more opportunity for fraud than Election Day in person voting. However, if your state legislates Mail In ballots like Maryland, you should use them. Why?

1. They are safe. The ballot is sent to you with a unique return envelope which is the only one the elections board will accept. Without the return envelope the ballot will not be counted.
2. They are secure. This is especially true if the ballot is returned in the ballot drop box. The drop boxes are more secure than the Post Office.
3. They are reliable. **Can you** be absolutely, positively, sure you will get to the polls on Election Day? You won't be sick, have an emergency, etc. No, you can't.
4. They provide protection against fraud. In the unlikely event some fraudster uses your identity to obtain your Mail In ballot you have time to challenge this. You will get your lawful ballot and void his illegal ballot. If you wait until election day, it may be too late. The fraudulent ballot may be counted and yours may not.
5. They are convenient. You can study the candidates and issues before you vote.
6. Elections matter, they determine who will legislate and thus the future election system. Using the current election system is the ONLY way to affect future changes.
7. Finally, you can track your ballot as it progresses through the process. Kinda like a package from Amazon.

Observer vs Election Judge:

Observer: Can watch the election process without interfering with the Election process. This could be at quite a distance where detailed overview of Election processes is minimal. Ability to intervene immediately may be diminished due to no official authority to interrupt or question the process.

Election Judge: Part of the Election process. Judges are present when equipment is configured and initialized before Election Day begins. Judges are also present after Voting closes and are part of the final processing, closure of the equipment, reconciliation, and shut down of equipment. Election Judges are paid for training, set up the day before the Election, and working Election Day. If an election judge sees an issue, this judge can become involved immediately in the process to resolve the issue.

If you are truly concerned about Voter Integrity, then insert yourself in the place that will give you the authority to correct voting issues while these issues are occurring. I have included a link to the Board of Elections - Election Judge page.




